95. PLANNING APPLICATIONS

Planning applications submitted by Conwy County Borough Council were considered and in exercise of plenary powers, recommendations made thereon (Appendix A).

Cllr Gl Davies declared a prejudicial interest in application 0/43726 and left the room for this item. Cllr G J T Robbins declared a prejudicial interest in application 0/43706 and left the room. The Vice-Chairman took the Chair for this item.

Cllr Miss A O'Grady asked that her abstention be recorded on planning application 0/43677. Cllr T R Davies and Cllr Mrs D Good asked that their abstentions be recorded on planning application 0/43706.

96. NOTIFICATION FROM CONWY COUNTY BOROUGH COUNCIL OF PLANNING APPLICATIONS DETERMINED

Notifications <u>were received</u> from Conwy CBC of applications determined between 30.01.17 and 29.01.17 including:

- Copy of refusal notice on application 0/43510, 37 Glan Y Mor Road, Pernhyn Bay
- Copy of split decision on application 0/43569, Unit 10 Par Llandudno, Conway Road, Llandudno

With reference to the decision on application 0/43510, a member queried whether the grammatical errors on the sign wording had been corrected as per the recommendation of the Town Council. The Chairman reported that the work on the signage had not yet been undertaken.

97. CORRESPONDENCE/CONSULTATIONS

- **97.1** Additional information from Conwy CBC regarding the Active Travel Act following a presentation at the February meeting of the Planning & Transportation Committee <u>was</u> received.
- 97.2 Members discussed a copy of a letter to Conwy CBC Highways received from Llandudno Civic Council, proposing a reversal of the one-way system on the Promenade end of Church Walks, Llandudno. Members noted that there were issues with vehicles traversing the one-way system on Church Walks in the wrong direction but queried whether the problem was due to inadequate signage.

The Chairman reported that this issue had been raised three years ago, and had led to improved signage including painted road markings denoting the one-way system. The road markings, however, were no longer visible and the no left turn sign was also no longer there.

Members considered that the reversal of the one-way system would lead to increased traffic congestion in the town centre particularly by Carlton Island roundabout and Upper Mostyn Street and <u>IT WAS RESOLVED</u> to write to inform the Civic Council that after deliberation, the Town Council considered that the one-way system on Church Walks should remain as at present.

IT WAS FURTHER RESOLVED to write to Conwy CBC to request that the signage be updated, the road markings re-instated and signage installed lower down Church Walks to alert drivers in advance of the one-way system.

- 97.3 Email from Conwy CBC regarding Community Transport in Conwy and the creation of a Community Transport Development Group was discussed and <u>IT</u>

 <u>WAS RESOLVED</u> that Cllr Mrs P Hebron would attend on behalf of the Town Council.
- 97.4 Consultation by the Welsh Government on draft circular for the planning of gypsy,

traveller and showpeople. It was noted that the closing date for the consultation was 22nd May 2017 and <u>IT WAS RESOLVED</u> to refer the consultation to the April meeting of the Planning & Transportation Committee to allow members more time to consider the consultation documents.

97.5 Notification from Conwy CBC of Planning Committee Site Visits to be held on Tuesday 7th March 2017 and <u>IT WAS RESOLVED</u> that Cllr T R Davies would attend.

98. DATE OF NEXT MEETING

The date of the next meeting was confirmed as Wednesday 5th April 2017. As Conwy CBC would no longer send out paper copies of planning applications after 1st April 2017, <u>IT</u> <u>WAS RESOLVED</u> that future meetings of the Planning & Transportation Committee would start at 6.00 pm to allow members additional time to view planning applications via Conwy CBC's planning explorer portal.

IT WAS FURTHER RESOLVED to recommend to the Finance & General Purposes Committee the purchase of a hi-resolution projector and screen to facilitate the viewing of planning applications via Conwy CBC's planning explorer.

IT WAS FURTHER RESOLVED to recommend that an additional computer be purchased, for the Parlour, including appropriate cabling/wi-fi, to allow those members without access to the internet to view planning applications.

Members noted that the meeting due to take place on Wednesday 3rd May 2017 was the evening before the Local Government Elections and <u>IT WAS RESOLVED</u> to reschedule the meeting to Tuesday 2nd May 2017.
