97.3 Correspondence received from Conwy CBC in response to a letter from the Town Council requesting consideration of the installation of a pedestrian crossing on Glan Y Mor Road, Penrhyn Bay was discussed.

Members expressed disappointment with the response from Conwy CBC disagreeing that there was insufficient evidence to obtain Welsh Government Funding for the installation of traffic calming measures. It was raised that funding had been obtained to improve the sea defences at Penrhyn Bay, which included an amenity element and it was suggested that some of this funding be used to provide a pedestrian crossing on Glan Y Mor Road. However, there was concern that the lack of evidence argument would also be used by Conwy CBC in relation to other funding.

<u>+IT WAS RESOLVED</u> to write a strongly worded letter to Conwy CBC that members considered that there was sufficient evidence to support the installation of traffic calming measures on Glan Y Mor Road and that funding should be found by any means.

IT WAS FURTHER RESOLVED to state that the Town Council had campaigned for traffic safety measures in this area for a number of years and should any injuries or fatalities occur, Conwy CBC would be responsible and as the information collated by the Town Council on this matter over the last three years, having been through Council, was in the public domain, it would be provided to any claimant upon request.
