### 40. UPDATE FROM THE LLANDUDNO IN BLOOM SUB COMMITTEE ON LLANDUDNO'S SUCCESSES IN WALES IN BLOOM 2019

The Vice Chairman, Llandudno in Bloom Sub Committee, reported on Llandudno's successes in the Royal Horticultural Society's Wales in Bloom 2019. In addition to Llandudno achieving Gold in the 'Coastal' category and Ysgol San Sior 1st Place in the School Garden category, many groups in the Town had celebrated sucess in the 'It's Your Neighbourhood' Awards. These included, Level 5 Outstanding to the Friends of Queen's Park, Happy Valley and West Shore, and Blind Veterans UK.

#### **42. ACCOUNTS AND AUDIT**

The Town Clerk was pleased to report an unqualified audit from external auditors BDO and that there had been no issues arising.

<u>IT WAS RESOLVED</u> to approve and accept the Annual Return and External Audit report for 2018/19.

IT WAS RESOLVED to record a Vote of Thanks to the Town Clerk and staff for the excellent external audit report for the year ending 31 March 2019.

# 43. LLANDUDNO PLAY AREAS AND RELEASE OF ALLOCATED BUDGET 2019/20

The Town Council had allocated £24,000 in its budget for 2019/20 towards the maintenance of play areas within the Llandudno community area by Conwy CBC and the release of any funding was subject to consultation with the Town Council.

Members considered a spreadsheet and information received from Conwy CBC outlining proposed works for various Llandudno play areas and a priority rating. It was understood that Conwy CBC also committed funding towards works and had in

2019 spent around £13,000 on play areas in Llandudno. High priority projects put forward by Conwy CBC included Canol Creuddyn, West Shore, and Mostyn Play area. There was discussion on the number of play areas in the Llandudno area, around 30, and that the demographic of sites had changed over the years resulting in changes in the usage of sites. Members were of the view that the Town Council's contribution should be deployed to the most used play areas. Members noted the recent survey by Conwy CBC on usage of play areas within the Conwy area and discussed whether any rationalisation of sites might be needed, going forward.

IT WAS RESOLVED to defer any decision and to convey to Conwy CBC that the Town Council wished to use its £24,000 play area budget for Llandudno sites that had the most usage and to ask for a detailed breakdown of maintenance requirements and costs for these.

#### 44. LLANDUDNO ANNUAL WELL BEING REPORT

Members had been circulated with the final copy and design of the Town Council's Well-being report for 2018/19, and which <u>was received</u>. The draft had been approved previously, but it had required a final artistic design, which would be used annually.

#### **47. TOWN HALL LEASE WORKING PARTY**

To receive a report from the Town Hall Lease Working Party, 26<sup>th</sup> September 2019. **Exempt Information EX 14/2019** 

IT WAS RESOLVED that in view of the confidential nature of the business about to be transacted, it is advisable in the public interest that the press and public be temporarily excluded from this item under Standing Order 37, and they were instructed to withdraw. The reason for the exemption being the consideration of contract information relating to the Town Council's occupation of offices within the Town Hall.

Cllr Mrs C Beard, Cllr F Bradfield, Cllr PC Evans, JP, Cllr GJT Robbins and Cllr HTM Saville declared prejudicial interests and left the room for this item.

The Working Party Chairman and Vice Chairman updated members on ongoing discussions with, and advice from, the Town Council's Solicitors regarding the proposals from Conwy County Borough Council for the Town Council to enter a new lease for its occupation of the Town Hall, and the offer of additional office space in the building. The working party had considered in great detail the options for the existing office accommodation and the lease of further rooms, the costs and terms and conditions of the proposed leases, and the Town Councils needs in terms of office

space. The Working Party submitted a recommendation to Council to enter into discussion with Conwy CBC, through the Town Council's solicitor, on the proposed new lease for the Town Council's current occupation and for additional space on offer. Council would be kept updated on discussions and ongoing reports would be made to Council.

IT WAS RESOLVED to accept and approve the recommendation of the Town Hall Lease Working Party to enter into dialogue with Conwy CBC regarding a new lease arrangement for the Town Councils' existing office space and for additional rooms offered within the Town Hall (former Arts & Business rooms, Chamber and small meeting room) and to bring back to Council a firmer proposal from Conwy Council and costs.

Members thanked the Chairman and Vice Chairman.

The public were invited to return. Cllr P C Evans JP returned to the meeting.
