#### **TRAVEL AND SUBSISTENCE EXPENSES**

Determination: Community and Town Councils may continue to make payments to their members in respect of travel costs for attending approved duties outside the area of the Council. Such payments must be actual costs of travel by public transport or the HMRC mileage allowance, including as below:

- 45p per mile up to 10,000 miles in the year.

Determination: Community and Town Councils may continue to reimburse subsistence expenses to their members for attending approved duties outside the area of the Council at the maximum rates set out below on the basis of receipted claims

- £28 per day allowance for meals
- £95 overnight/£120 Cardiff/£150 London
