112. CORRESPONDENCE/CONSULTATIONS

112.1 Notification from Conwy CBC of Planning Appeal on planning application 0/47162, Eithinog, Skerryvore Road, Bryn Pydew, Llandudno *was received*.

112.2 Notification from the Planning Inspectorate of consultation on the application by Awel y Môr Offshore Wind Farm Limited for an Order granting development consent for the the Awel y Môr Offshore Windfarm was considered.

Members had initially discussed the proposals at the meeting of the Planning & Transportation Committee held on 3rd June (Minute: 104.1) and reiterated their previous comments. These included concerns that the granting of development consent for Awel y Môr would cause damage to the marine environment and would have a detrimental impact on the tourism industry in Llandudno. Members were also concerned that the decision on the proposals may have already been agreed and noted that Conwy Councillors had previously been attacked by some Members of Parliament for not supporting the wind farm project. It was also noted that the decision to grant development consent came under the UK Government and not the Welsh Government.

IT WAS RESOLVED to write to the Planning Inspectorate that the Town Council recommended refusal of the application for development consent for the Awel y Môr Offshore Wind Farm on the grounds that it would have a detrimental effect on the tourism industry in Llandudno and on the conservation of an area of special heritage coast.

IT WAS FURTHER RESOLVED that the Chairman and Cllr I Turner would draft the Town Council's submission; to include Minute 104.1 from the meeting held on 3rd June 2020 and also the information previously circulated regarding the Constable Bank, natural sea defence off the coast of Llandudno and a copy of the petition signed by the Town Council, residents and tourism businesses raising concerns about the 'Gwynt Y Mor' windfarm, from 2007.
